We are committed to excellence and offer individualized treatment based on your needs, wants, and desires. Our focus is on the whole patient, so we consider how your overall health and medical conditions affect your gums and teeth. The fee for your Periodontal Examination is \$235. A \$50 deposit is required when scheduling your appointment. The balance of \$185 is due upon completion of your Periodontal Examination. We accept cash, personal checks, Visa, Mastercard and Discover. There is a 3% processing fee for credit cards; there is no processing fee for debit cards, HSA cards, cash or checks.

We will be happy to file with your dental insurance as a courtesy to you. We are not in-network with any dental insurance company. **It is your responsibility to check your eligibility and your payable benefits.**

**If your doctor requires you to take a prophylactic antibiotic/pre-medication for dental appointments, please make sure to take the medication as directed by your doctor for your first appointment.**

If the patient is a minor, his/her parent or legal guardian will need to be with the minor for the Exam.

Your appointment time is reserved specifically for you and Dr. Hill. If you are unable to keep your scheduled appointment, please give us 48 hours advance notice. **The fee for a missed/failed New Patient Periodontal Exam appointment is \$235.** If the appointment is failed, an additional \$235 will be required to schedule another appointment.

We strive to see patients at their appointed time, therefore, if you are more than 15 minutes late, we will have to reschedule your appointment. If an appointment is failed or needs to be rescheduled a second time, payment in advance will be required to reschedule and is non-refundable. If 3 appointments are failed or rescheduled with short notice, you may be dismissed from our practice.
